ADDENDUM 'A'

Proposal to Leadership Team to Expand our Outreach Ministry March 2017

For many years, Crescent Fort Rouge United Church (going back at least to the days of the Vietnamese “Boat People” in the 1970’s) has been involved in the support and settlement of refugees to Canada. We all know that the demand for support of this work right now is perhaps greater than it has even been. The influx of refugees from Syria and other countries in that region as well as the current influx of asylum seekers across the Canada/USA border in communities such as Emerson are evidence of the need. We also recognize that here at CFRUC our volunteer capacity and the level of our other resources limit us from being as involved as we once were and as we might like to be right now.

In light of this, we wish to propose that Crescent Fort Rouge U C establish a new partnership with a community group that is already at work in refugee sponsorship. This would enable us to expand our Outreach ministry in support of refugees. In turn, we would be supporting the community group by providing financial/administrative support in their work.

The community group is called Reaching Out Winnipeg (ROW). ROW is a program that started in 2012 to promote resettlement of LGBT refugees and asylum seekers in Winnipeg and beyond. They aim to be a hub of information and resources on LGBT resettlement and how to get involved to potentially save the life of international LGBT refugees. They have facilitated the efforts of several “groups of five” and have so far sponsored seven refugees. This is their stated purpose: “To relieve suffering and distress of SGM people whose human rights as defined by the United Nations Convention and Protocol Relating to the Status of Refugees are being abused in foreign countries of origin because of their gender identity or sexual orientation by assisting them to resettle in Canada.”

ROW has not yet been able to gain status as a Registered Charity. By formally “adopting” the work of ROW as an outreach program of CFRUC donations designated to support their work would be received and receipted by CFRUC in the same way as we now do with all donations for our work. Disbursements authorized by ROW for their work would be made by the Office Administrator of CFRUC under the usual guidance of the Treasurer and Finance Committee.

We have been in consultation with legal counsel, financial services, and refugee staff in the United Church of Canada General Council Office in Toronto. They have assured us that this activity would be in full compliance with the regulations of the Canada Revenue Agency. They have provided us with examples of what others have done in similar partnerships. They have also provided templates for formalizing our relationship with ROW.

If we were to agree to this partnership and if ROW agreed to this it would be advisable to set up a new separate account with our bank to handle the funds for this project.

This concept was discussed at the recent meeting of PATH 2 where there was agreement that it “fits” with what we heard from broad consultation within our congregation about how we want to go forward. Outreach came out very high on the scale of importance. Outreach to seniors and children/youth were two areas in particular focus and work is underway toward expansion there. Those endeavours would see partnerships with Fort Rouge Children’s Centre and Gladstone School. We believe that this proposed new partnership would be further expansion of our outreach ministry and would not involve a significant amount of either volunteer or financial resources. It is reassuring that ROW has a track record of about five years, has been very successful and has wide community support and recognition.
